### Program Purpose and Authority

The Volunteer Service Scholarship Program is a form of **need-based tuition assistance** approved by Limestone Christian Academy. This program supports the school's mission by encouraging active parent partnership while maintaining fiscal responsibility and program sustainability. Participation in this program is voluntary and subject to administrative approval.

### TEFA Funding Requirement

Families applying for LCA Tuition Assistance must first apply for funding through the Texas Education Freedom Account (TEFA) program before seeking school-based financial assistance.

Please note: Families who receive funding through TEFA will not be eligible to receive additional tuition assistance from Limestone Christian Academy.

### Scholarship Terms

By electing this option, the family agrees to earn **four (4) approved volunteer service points** to offset the portion of tuition not covered by direct financial payment.

- Total tuition balance eligible for coverage through this program: **\$5,500**
- Required volunteer commitment: **4 points** completed within the designated school year

Volunteer service points have no cash value and may only be applied as tuition assistance for the school year listed above.

## Tuition After Application of Volunteer Service Scholarship

Upon approval and completion of required volunteer service points, tuition will be adjusted to the assisted rates below, which include a 10% sibling discount for the first sibling and 15% for each additional sibling.

- **One-student family:** \$375.00 per month (\$4,500 annually)
- **Two-student family:** \$712.50 per month (\$8,550 annually)
- **Three-student family:** \$1,031.25 per month (\$12,375 annually)
- **Four-student family:** \$1,350.00 per month (\$16,200 annually)

These rates reflect tuition after application of the Volunteer Service Scholarship and are contingent upon fulfillment of all requirements outlined in this agreement. Failure to complete required volunteer service may result in tuition being recalculated at the standard rate.

## Approved Volunteer Service Activities

Parents/guardians must initial next to each selected commitment. A total of **four (4) points** is required.

### One (1) Point Activities

- \_\_\_ Join PTO and attend a minimum of 50% of scheduled meetings
- \_\_\_ Join a Growth Committee and attend a minimum of 50% of annual meetings
- \_\_\_ Attend a minimum of 50% of Enrichment Fridays

### Two (2) Point Activities

- \_\_\_ Assist with school workdays and approved project completion for safety or fundraising
- \_\_\_ Maintain student drinking water bottles and school snacks
- \_\_\_ Serve as a dismissal agent one day per week
- \_\_\_ Assist in coaching any sport
- \_\_\_ Assist with annual fundraising activities
- \_\_\_ Serve as Growth/Expansion Committee Chairperson
- \_\_\_ Serve as Herzog Foundation Committee Member
- \_\_\_ Serve as Library Committee Member

### Four (4) Point Activities

- \_\_\_ Serve as Library Committee Chairperson
- \_\_\_ Serve as Herzog Foundation Chairperson
- \_\_\_ Coach any sport for a full season
- \_\_\_ Serve as Room Mother (maximum of two parents per classroom)
- \_\_\_ Assist with Cultural Arts productions
- \_\_\_ Serve as PTO Office Holder
- \_\_\_ Serve as a Morning Greeter one day per week



## Compliance, Documentation, and Oversight

- Volunteer activities must be **pre-approved** by school administration.
- Completion of volunteer service must be **documented and verified** according to school procedures.
- The school reserves the right to reassign volunteer roles based on operational needs.
- Service hours and responsibilities must be completed in a manner consistent with school policies, safety standards, and conduct expectations.

---

## Non-Completion and Financial Responsibility

Failure to complete the agreed-upon volunteer service requirements by the end of the school year may result in:

- Prorated or full **reinstatement of the outstanding tuition balance**, and/or
- Adjustment of tuition assistance reflected in the family's FACTS account.

The school retains sole discretion in determining satisfactory completion.

---

## Term and Limitations

- This agreement applies only to the school year specified above.
- Volunteer service points are **non-transferable** and may not be carried forward.
- This agreement does not guarantee continued eligibility in future school years.

---
